What types of businesses are covered?

Smart, safety managed Illinois manufacturers with minimal occupational disease exposure, limited chemical exposure and no hazardous material handling. Through a lengthy screening process, the WCTI Board of Trustees approves or declines all potential new members.

Who provides excess insurance?

Safety National Casualty Corporation, an A rated carrier by A.M. Best.



Ownership

Members are the owners of WCTI and ultimately control its management through participation on its Board of Trustees.



Loss Prevention

Members are provided with proactive safety consultation by trained loss control professionals to assist in the prevention of all workplace injuries.



Aggressive Claims Management

An experienced team of claims professionals assist members in controlling and reducing claim costs. Legitimate claims are paid promptly. False claims are aggressively defended.



Managed Care Program

The WCTI managed care program includes telephonic nurse case management, a Preferred Provider Organization (PPO) and pre-negotiated discounts for non-PPO providers.



Prescription Drug Program

Injured employees are sent a prescription drug card that will cover their costs in full. Members of WCTI receive savings on the cost of the medication, and the cards are activated for medicine related only to the injury.



Prompt Reporting

Each member receives a monthly report of all claims, reserves and an itemized check register. A detailed information report on all open indemnity claims is received quarterly.
